- b. **Multiple Amendments/Options Exercised:** As the **Price Agreement** represents a **State Price Agreement (CORE #2015-0000-0000-214)** for **Facilities Maintenance, Repairs and Operations "MRO"** for two (2) **Category Groups (Category Group 2 - Hand Tools, Power Tools and Accessories; and Group 8 - General)** where unit pricing is established, the amount of the current fiscal year value has not changed as consideration for goods/services ordered under the **Original Price Agreement** effective **02/06/2015**, as amended for the current fiscal year **2016**.
- 3) **Effective Date.** The effective date of this **Option Letter** is upon approval of the State Controller or others delegated; whichever is later.
