- b. Outside Delivery Zones. Outside of our normal delivery area the following delivery charges apply.
 - Minimum order is \$400.00 minimum or a \$40.00 small order charge shall be applied as well as freight charges, on a freight prepaid and added basis.
 - The same pricing and delivery parameters shall prevail for any subcontractors Waxie utilizes for contract fulfillment in states where we do not operate.
 - Waxie will waive delivery charges for customers outside the normal delivery area if those customers that are willing to work with us on order size and delivery schedule.

- 2. Online Ordering: Web at work online ordering system that allows for the following at no charge.
 - Real-time inventory levels at the appropriate shipping locations
 - Real-time order status
 - Accounts payable information
 - Real-time open invoices
 - Real-time paid invoices with detailed payment history and information
 - Ability to research previous order information
 - Ability to research product usage by ship-to and export data in excel, word or PDF format
 - Ability to place orders online with secured checkout
 - Custom shopping lists
 - Access to MSDS 7/24
 - Detailed product information including pictures and specifications
 - Suggested alternate and replacement items
 - Ability to have multiple order approval levels
 - Multiple email confirmations
 - Search and order by either customer item number or vendor item number
 - Select multiple shipping locations by user
 - Ability to utilize General Ledger numbers for each item
 - Option to hide product pricing from specified users
 - Budget control by month, annually, or by dollar limit.

Note: State of Colorado customers using Web at Work will be among the first to experience the new system upgrade in July 2013.

- 3. <u>Additional Discounts Possible</u>: There are a number of areas where customers and WAXIE can work together to reduce costs, prices, and the impact of the contracts fulfillment on the environment.
 - Waxie Brand Conversion: Waxie is offering an additional discount for customers switching to Waxie branded cleaning products. An additional discount of up to 2% is available.
 - Minimum Order: A minimum order dollar amount could be implemented that would reduce the number of transits dramatically. The largest contribution to environmental impact fulfillment of the contract has is the amount of fuel used to get product from our warehouses to our customers. WAXIE can provide detail regarding these impacts and would look to negotiate a pricing reduction if a minimum order is incorporated into the contract. Customers agreeing to a minimum order of \$400 can receive up to a 1% discount on all orders.
 - Scheduled Delivery: Another effective way to impact costs is to work with customers to schedule delivery. For customers with large capacity warehouses this enables both WAXIE and the customer to best utilize their labor and capital resources. For instance our overall business sees 65-70% of product moved the first and last week of the month. We routinely work with large clients to schedule delivery during the slower periods of the week and month to optimize our labor and capital resources. WAXIE is interested in negotiating a price concession with the Colorado customer if the customer is willing to allow a scheduled delivery program to be part of this contract. Customers agreeing to schedule delivery, reduce the number of deliveries by half and agree to receive orders on a mutually beneficial schedule may receive up to a 1% additional discount on all orders.
 - Electronic Payment: Automated Clearing House/Electronic Funds Transfer payment can substantially reduce the time between invoice and payment.  content, or use high density liners, can receive up to a 1% discount on all purchases.

- 5. Consulting Services. Consulting services will be provided in the following areas, provided at no charge:
 - a. Cleaning Chemical use and care provided through WAXIE Chemical Specialist and manufacturers' representative.
 - b. Equipment operation and maintenance training provided through WAXIE Equipment Specialist and manufacturers' representative free of charge.
 - c. Training and Education will be provided through WAXIE Sanitary Supply's monthly seminars at each of our location, through online webinar and at the customer's location.
