1) **OPTIONS.** Option to renew for an additional term.

2) **REQUIRED PROVISIONS.**

- a. In accordance with **Exhibit A, Section 3.A. Term** of the **Participating Addendum** between the **State of Colorado, State Purchasing Office**, Department of Personnel and Administration ("State") and **Mohawk Resources LTD.** ("Contractor"), the State hereby exercises its option for an additional term beginning **January 1, 2016** and ending on **June 30, 2016** at the same rates and same terms specified in the **Original Participating Addendum** as amended. Unless specified in this **Option Letter**, there shall be no change to the current **Participating Addendum** value as a result of this extension to the term.
- b. **Multiple Amendments/Options Exercised:** As the **Participating Addendum** represents a **State Price Agreement (#07544YYY01M/NASPO previously #07544YYY01M/WSCA, and CORE #2015-0000-0000-0130)** where unit pricing is established, the amount of the current fiscal year value has not changed as consideration for goods/services ordered under the **Original Participating Addendum** effective 09/25/2007, as amended for the current fiscal year **2016**. The **Participating Addendum** shall have been amended as follows: **Amendment #1** dated 08/01/2008; **Amendment #2 (CMS #54419)** effective 03/28/2013; **Option Letter #1 (CMS #65143)** effective 02/04/2014, **Option Letter #2 (CMS #77563)** effective 03/20/2015, and **Amendment #3 (CMS #80736)** effective 06/24/2015.
- 3) **Effective Date.** The effective date of this **Option Letter** is upon approval of the State Controller or others delegated; whichever is later.
