- Seller shall have the right to deny any credit application or to deny any additional extension of credit if there is a delinquent balance.
- Service charges may be assessed on past due balances at the rate of 1 1/2 % per month or the highest percent permitted by law, whichever is less.

2. TERMS OF SALE

- All amounts charged by the Applicant will be due Net 30 days from date of invoice or later date as specified on the invoice and SERVICE CHARGE may be imposed on this account if said account is not paid on the date amount comes due.
