### 1. PARTIES

This Amendment to the above-referenced Original Contract (hereinafter called the Price Agreement) is entered into by and between **Proforce Marketing**, **Inc. dba Proforce Law Enforcement** (hereinafter called "Contractor"), and the **State of Colorado**, acting by and through the Department of Personnel & Administration, State Purchasing & Contracts Office (hereinafter called the "State"), and collectively referred to as the "Parties."

### 2. EFFECTIVE DATE AND ENFORCEABILITY

This Amendment shall not be effective or enforceable until it is approved and signed by the Colorado State Controller or designee (hereinafter called the "Effective Date"). The State shall not be liable to pay or reimburse Contractor for any performance hereunder including, but not limited to, costs or expenses incurred, or be bound by any provision hereof prior to the Effective Date.

### **3. FACTUAL RECITALS**

- **A.** The Parties entered into the Price Agreement effective August 3, 2017 for the provision of Law Enforcement Duty and Training Ammunition, as set forth in the Price Agreement, contract number 201800000000000000103.
- **B.** The Price Agreement was extended through July 31, 2020 by issuance of Option Letter #1, CMS #140593.
- **C.** The Price Agreement was amended to revise the product offerings, and extend the contract through July 31, 2021, through issuance of Amendment #1, CMS # 162851.

#### 4. CONSIDERATION

The Parties acknowledge that the mutual promises and covenants contained herein and other good and valuable consideration are sufficient and adequate to support this Amendment.

#### 5. LIMITS OF EFFECT

This Amendment is incorporated by reference into the Price Agreement, and the Price Agreement and all prior Amendments thereto, if any, remain in full force and effect except as specifically modified herein.

#### 6. MODIFICATIONS

This Amendment shall modify Exhibit B-1 of the Price Agreement, to remove Remington LE ammunition, and replace it with Aguila LE ammunition. Exhibit B-1 shall now become Exhibit B-2, as per the attached. Further, all references in the Price Agreement to Exhibit B-1, shall now be a reference to Exhibit B-2.

#### 7. START DATE

This Amendment shall take effect on the effective date.

#### 8. ORDER OF PRECEDENCE

Except for the Special Provisions, in the event of any conflict, inconsistency, variance, or contradiction between the provisions of this Amendment and any of the provisions of the Price Agreement, the provisions of this Amendment shall in all respects supersede, govern, and control.

#### 9. AVAILABLE FUNDS

Financial obligations of the state payable after the current fiscal year are contingent upon funds for that purpose being appropriated, budgeted, or otherwise made available.
