After Hours Drop Off Fee	Charged to customers who drop the truck off before or after the dealers regular business hours.	\$10.00 Flat Fee	\$10.00 Flat Fee	The dealer has the option of charging or not charging this fee.
Cancellation Fee	Charged when a customer cancels a reservation within 48 hours of their pick-up time.	\$50.00 Flat Fee	\$50.00 Flat Fee	Fee will be waived on Colorado State Business Rentals. In as much as the State of Colorado does not take advantage of this and attempt at all times to cancel reservations prior to pick-up time.
Cleaning Fee	Charged to customers or dealers who return a truck that requires cleaning or has remaining goods that need to be discarded.	\$25.00 Flat fee	\$25.00 Flat Fee	The dealer has the option of charging or not charging this fee depending on the condition of the truck.
Customer Refueling Fee	Charged to customers who receive the truck full but return it less than full. Late Charges	Charged to customers who return the truck more than 60 minutes after the return date and time stated on the agreement.	Charge an additional day inc. accessories protection and all other charges and fees	Charge an additional \$75 per day and .75 per additional mile.	The only exception would be one ways that have pre-purchased additional days/miles at a discounted rate at the time of rental.
NO Show Fee	Charged to customers 24 hours after a scheduled reserved truck as not been picked up.	\$50.00 Flat Fee	\$50.00 Flat Fee	Fee will be waived on Colorado State Business Rentals. Budget Truck Rental does not require a CDL License, however it is suggested that each state review the DOT regulations for states in which they intend to service or drive.	\$18.00 per day	\$18.00 per day	There are no exceptions
